#### 2020 BPLA BOARD ACTIVITIES AND ACCOMPLISHMENTS



- Successfully lobbied and petitioned the City of Crosslake to postpone the unnecessary replacement of Big Pine Trail this summer
- Successfully petitioned Governor Walz to include dock and boat lift workers as essential workers under his stay-at-home executive order
- Assisted the Crow Wing SWCD in issuing a contract change order that allowed Pine River Fish Passage Project (PRFPP) construction to begin in January 2020
- Worked closely with SWCD throughout the three month PRFPP construction period
- Formally rebid and negotiated a new lowest-cost multi-year mosquito management contract
- Coordinated with members and modified rules for the 2020 Big Pine Lake Independence Day Boat parade
- Worked with Crow Wing County Finance Department for BPLA to be reimbursed for \$3,900.00 in previous PRFPP development expenses
- Executed new 10-year lease with the MN DNR for the site that hosts the Big Pine Trail name plaque display. The cost of the lease is \$50.00 per year
